4. On finding sub-standard quality as and when noticed during process, the deposit bid security may be forfeited in favor of the Corporation and the tender may be treated as cancelled.
5. The Firm/Suppliers in question will be bound to supply the required items within 15 days from the issuance date of supply order, on the address provided when ordered. The mentioned tender is Valid for a period of 1 Year and_all the orders will be placed accordingly to our budget and need.
