



NOTE :- CORRIGENDUM IS ISSUED AS KAMERA KRAFT WAS INITIALLY REJECTED ON TECHNICAL GROUNDS BUT AFTER REDRESSING HIS GRIEVANCES AND GETTING CONSENTS FROM COMPETITOR BIDDERS , HE HAS BEEN GIVEN THE CHANCE TO QUALIFY TECHNICALLY .

IN INITIAL EVALUATION ONLY M/S QUICK PROCESS WAS THE WINNER OF ALL 3 ITEMS ( PRINTING OF CARDS, LEAFLET & BROCHURE), BUT CORRIGENDUM IS ISSUED AS GRIEVANCE BIDDER (M/S KAMERA KRAFT) IS ACCEPTED AS WINNER IN 1 ITEM (PRINTING OF CARDS).
