The Second envelope containing the price tender documents shall be clearly marked as “FINANCIAL BID DOCUMENTS” accompanied with Bid Security.

Tenderers may obtain the Tender Documents on submission of a written application and upon payment of a non–refundable fee in shape of cash / Pay order drawn in favour of State Life form “ Real Estate, 1st Floor, State Life Building , 15- Davis Road, Lahore ” during Office hours (Postal Correspondences will not be entertained).

Two Envelopes “Technical Qualification Information” and “Financial Bid Documents” must be delivered at “Real Estate, 1st Floor, State Life Building, 15- Davis Road, Lahore ” at or before 14: 00 PM on above mentioned date. The Envelope “Technical Qualification Information” shall be opened at 14 :30 PM on the same day.
