"TECHNICAL QUALIFICATION INFORMATION" and "FINANCIAL BID DOCUMENTS" [both envelopes] must be submitted at the under-mentioned address by **11:00 am** on Tender Submission date. The envelope containing "TECHNICAL QUALIFICATION INFORMATION" shall be opened on the same date at **11:30 am** in the presence of those Bidders or their representatives who wish to be present. Tenders received after the prescribed date and time will not be entertained.
6. The Financial Bid Document shall be returned **unopened** to those bidders who could not Pre-Qualify "Technical Bid". The decision of State Life Insurance Corporation in this connection shall be final and binding on the Bidders. State Life Insurance Corporation shall not entertain any claim on the basis of cost incurred by the Bidders for preparation of the Tender.
