4. The bidders will attach their respective copies of NTN and Sales Tax Certificates.
5. At the evaluation of received bids, the bidder would be required to provide the sample of item for inspection of their specification/quality and finalize the committee of relevant item. The committee is competent to right the reject the bid to substandard quality/specification.
