- 3 Bids shall be dropped / delivered by hand in Dispatch Section, P&GS Deptt, Sialkot Zone upto Tender Closing Time Bids will be opened in the office of Incharge Personnel & General Services Department, Siddique Plaza, Paris Road, Sialkot Zone in presence of bidders or their authorized agents who may attend the bids opening occasion at specified time & date. The authorised agent / representative hold authority letter with full authority to satisfy the management of State Life regarding specifications, price etc on the occasion, otherwise quotation of those having no authority letter will be rejected.
