#### 1. INSTRUCTION TO BIDDERS (ITB)

#### 1.2 Eligible Bidders

An owner or lawful Attorney of the Owner, having active National Tax Number (NTN), of the Property meeting with the Criteria provided in Clause 1.5.2 herein.

#### 1.3 Preparation of Bids

#### 1.3.1 Bidding Process

This is the Single Stage - Single Envelope Procedure (Clearly mention tender No. on envelop)

#### 1.3.2 Cost of Bidding

The bidder shall bear all costs associated with the preparation and submission of its bid and SLIC will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

#### 1.3.3 Language of Bid

The bid prepared by the bidders as well as all correspondence and documents exchanged by the bidder and SLIC must be written in English.

#### 1.3.4 Bid Currencies

- ➤ All prices quoted must be in Pak Rupees.
- Rs.195,000/- in the form of CDR/Pay order in favour of State Life Ins. Corp. of Pakistan which is 3% of estimated annual cost i.e. Rs.65,00,000/-.

#### 1.4 Submission of Bids

#### 1.4.1 Sealing and Submission of Bids

The bid shall comprise a Single package containing:

- ➤ Signed Form A (Eligibility Criteria) with following documents.
- a) Copy of CNIC of the Bidder (Owner of the Property);
- b) Certified copy of Ownership Documents;
- c) Copy of Documentary proof of approved Commercialization of building from relevant Government building regulatory authority;
- *d*) Affidavit on Rs.300/- Stamp Paper assuring that the building is free from any dispute, litigation and clear from any encumbrance like pledge/guarantee.
- e) Any other relevant Document / information.
- ➤ Signed Form B (Financial Proposal);

#### 1.4.2 Clarification of Bids

No bidder shall be allowed to alter or modify his bid after the closing time for submission of the bids.

The SLIC may, if necessary after the opening of the technical bid, seek and accept such clarifications of the bid as do not change the substance of the bid.

Any request for clarification in the bid, made by the SLIC and its response, shall invariably be in writing.

SLIC shall also have right to ask or demand any additional information or document for the purposes of its satisfaction and clarification during the procurement process.

#### 1.4.3 Rejection of Bidders

SLIC shall summarily reject following Bids:

- a) Any Bid received after the Closing Date & Time i.e. 3rd June, 2024 at 11:00 AM;
- b) Any Bid received in Open or unsealed Envelope;
- c) Any Bid received incomplete;
- d) Any Bid containing false information or fake documents;
- e) Any Bid submitted in contradiction with Bidding Documents, etc.

#### **1.5** Opening and Evaluation of Bids

#### 1.5.1.Opening of Bids by SLIC

The date for opening of bids and the last date for submission of bids shall be the same (i.e. 3<sup>rd</sup> June-2024); and bid shall be opened on or after 11:30 am in the office of Regional Incharge (HR & Admin.), Regional Office, Central Region, 15-A, Davis Road, Lahore. Bid shall be opened in the presence of the bidders or their representatives who may wish to be present with authority letter.
