Terms & Conditions:

- 1. Only Income tax and Sales Tax registered (active tax payers) vendors/General Order suppliers can participate in the tender through EPADS. Provide documentary evidence related tax registrations.
- Bidders are required to upload their bids on EPADS system as per laid down PPRA procedure for single stage single envelope method and clearly marked as "Flooring work at IT Department, SLIC Central Zone Lahore".
- 3. Bids can be submitted/uploaded at EPADS till closing time 11:15 AM on 24-06-2024.
- 4. Submitted bids shall be opened sharp at 11:45 AM on same day i.e., 24-06-2024, in the office of Secretary ZPC, HRA&P Department, State Life Insurance Corporation of Pakistan, Central Zone, 4th Floor, 4-Ghazi Ilm-ud-Din Shaheed Road (Lytton road), Lahore in the presence of bidders or their authorized agents, who wish to be present on the occasion.

- **5.** In case wherein on bid opening day, holiday announced by prevailing Government or Zonal Office could not operate due to unavoidable reasons, then bid opening meeting shall be held on very next working day.
- **6.** <u>SINGLE STAGE, SINGLE ENVELOPE PROCEDURE</u> will be followed as per PPRA Rules 2004 for evaluation of bidders.
- 7. Bid Security amount (Earnest money) of Rs.15,000/- (including taxes) in the shape of CDR/Pay order favoring "State Life Insurance Corporation of Pakistan" must be submitted by bidders at the address given in tender notice / documents before closing date & time, else bid will be rejected.
- 8. The Bid Security will be returned immediately to un-successful bidders after completion of formal procedure and to successful bidder immediately after completion of work. However, successful bidder will be required to submit performance guarantee of 5% (value of Job Order) in shape of bank guarantee (valid for at least 6 months) in favor of State Life Insurance Corporation of Pakistan which shall be released after six month of completion of job.
- 9. Tender is based on One Single Job as describe at 1st page
- **10.** Successful bidder will have to start job/work within 3 days after confirmed work order and must complete the job in all respects within a week (7 working days); otherwise retention money (CDR) will be forfeited. In addition to this liquidity damages as penalty may be imposed after expiry of 7 days, at 5% per day of the total quoted price.
- **11.** Sample PVC quality is available at IT Department.
- **12.** Warranty of job must be of one year against any type of defect, with free repair/replenishment of job/part of job within warranty period.
- **13.** Quote only **single rate for complete (Per sqft and total)**, which must be irrevocable, unconditional & inclusive of all taxes & expenses (if any).
- **14.** Validity of the rates/bid must be at least 90 days from the date of opening of bid, which may be extendable with mutual consent.
- **15.** The Quantity sqft may slightly vary over and above the mentioned in this tender documents, hence area measurement must be done before quoting rates, however payment shall be made as per approximate qty i.e., 1050 sqft.
- **16.** Competent Authority reserves the right to reject/cancel/withdraw any/all bid(s) or proposals at any time before award of contract without assigning any reason thereof.
- **17.** Payment shall be made after completion of job in all respects, after deduction of applicable Govt taxes as per prevailing laws.
- **18.** Eligibility criteria mentioned below must be observed and fulfilled. An Affidavit of Rs. 100 in this regard must be attached with the bid.
