# iv) <u>Tax Deduction</u>

All taxes at the rate prescribed under the tax laws of Pakistan shall apply on supply and installation of equipment to State Life and it will be deducted accordingly.

# v) Acceptance of Bids

a) The State Life Insurance Corporation of Pakistan reserves the right not to accept the lowest quoted rates and shall be authorized to cancel any proposal and to even cancel the bidding process without assigning any reason whatsoever before placing order under Rule 33(1) of PPRA-2004.

b) The quantity of the actual order placed may vary from the estimated quantity as mentioned in the advertisement Tender Notice.

### vi) Late Delivery of Equipment

State Life Insurance Corporation of Pakistan will deduct 5% of the bill amount, if ordered equipment is not delivered and installed within Two Weeks from the date of issuance of letter of award for the equipment. The letter of award will become void if equipment ;is not delivered and installed within Four Weeks of issuance of letter of award for the equipment and the bid bond of that ;specific item will be forfeited.

### vii) Incontestability

- a) The decision of State Life Management with regard to the evaluation process and its result shall be final and binding on all parties incontestably.
- b) In case of any dispute, the decision of the Management of State Life will be final. The decision of State Life will be binding to all bidding firms and in no case will be challengeable at any forum.

### viii) Announcement of Evaluation Report

Procuring Agencies shall announce the result of bid evaluation in the form of report given justification for acceptance or rejection of bids at least 10 days prior to the award of procurement contract.
