- ii. The contractor shall take maximum care of adjoining equipment and works. If any damage is caused to such items, the contractor shall rectify the same free of cost to the satisfaction of State Life Engineer.
- iii. The above parts shall be genuine, confirmation regarding genuity must be guaranteed. If the parts do not suit the chiller, those shall be replaced at bidder's own cost.
- iv. Rates shall be inclusive of the cost of parts, freight, insurance , duties ,taxes, surcharges, overhead and profit etc ,no claim shall be entertained for any extra or additional payment in this regard.
- v. The period for supply & installation of spare part will be sixty **(60) days**. Please note that time is the essence of this contract and in case of your failure to complete the work within the stipulated period, You will be liable to pay the corporation liquidated damages at the rate pf **Rs.5000/(Rupees Five Thousand Only)**per day subject to a maximum limit of **10%**of the quoted sum.
- vi. **75%** of the quoted price shall be paid after installation, testing & commissioning of parts for at least **15days** of satisfactory operation of chiller.
- vii. **25%** balance payment shall be paid after expiry of Guarantee period i.e. three **(03)months** after satisfactory operation of chiller.
- viii. Sealed bid should be delivered at 5th Floor SLB#.9,Dr Ziauddin Ahmed Road, Karachi in the office of AGM (Mechanical) RE on the date mentioned in the advertisement.
