The Second envelope containing the price tender documents shall be clearly marked as "FINANCIAL BID DOCUMENTS" accompanied with Bid Security.
5. Tenderers may obtain the Tender Documents on submission of a written application and upon payment of a non-refundable fee in shape of cash / Pay order drawn in favour of "State Life Insurance Corporation of Pakistan, Sargodha Zone" during Office hours.

Two Envelopes "Technical Qualification Information" and "Financial Bid Documents" must be delivered at "P&GS Department, 1st Floor, M.M Plaza, Queen's Road, Sargodha" at or before 11: 00 AM on above mentioned date. The Envelope "Technical Qualification Information" shall be opened at 11 :30 AM on the same day.
7. The "Financial Bid Documents" of Tenderers who fail to POST QUALIFY shall be returned UNOPENED. Upon technical verification, the envelope "Financial Bid Documents" of Post Qualified Tenderers will be opened at 11: 30 AM in the presence of Tenderers representatives on the date to be intimated in due course of time.
