TERMS AND CONDITIONS

- A)** Tender will be opened on 18-08-2017 (12:30) PM.
- B)** The bidding firm will submit CDR in favour of State Life Insurance Corporation of Pakistan, Jhang Zone @ 5% of the total value involved along with the quotation concerned as bid security which is compulsory.(Cheque will not be acceptable)
- C)** The bidding Firms or general order suppliers, in question, will be bound to supply the required item as a whole consignment within two week or so, relevant to the trade of his/her firm, from the date of issuance of purchase order/supply order. The quotations will be given only of unit cost of items in question.
- D)** All bidding firms will provide copies of their NTN & Sales Tax Registration No. along with bidding documents and will further furnish an undertaking that the same supplier is not black listed from any department. The biding firm showing the lowest rate on each respective and specified item

will be treated as the winner of the bid. The lower gross cost bidder will not be treated as winner except the criteria noted above.

E) Tender, duly completed in all respect, must be reached to the under signed by hand / by courier / by post till the closing date i.e. 18-08-2017 (12.00 Noon).

F) Income Tax & Sales Tax will be applicable as per Govt. of Pakistan rules from successful bidders and will be deducted as per rule.

G) No tender / quotation will be accepted other than the specification given in the tender. The number of each required item is noted against each which in approximate numbers and for evaluation of investment involved for the bidders. However, our purchase order will show the exact required number of each item along with its respective approved rate with total sum involved. The purchase order will be final and absolute, by keeping in view the capital budget allocation in the respective head.

H) Tender will be considered as valid for 90 days regarding S # 1 and 2 and for S# 3 whole remaining year i.e. up to 31-12-2017, once opened w.e.f. 18-08-2017. The items in question will be supplied by the lowest bidder at the below noted address of Zonal Office Jhang.

I) The Corporation may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The quantity of the items can be increased or decreased.

J) The delivery time of equipment is 15 days from the issuance of purchase order. Delivery of items to SLIC Jhang Zone shall be responsibility of the successful bidder. Rates quoted should include delivery charges. **No. transportation charges will be paid for delivery of equipment /Material at our Zonal Office Address. separately.**

K) Release of Bid Security; (Shall be released to un-successful bidders after the issuance of letter of award to lowest evaluated bidder) and to the lowest evaluated bidder on satisfactory completion of entire work as per term & conditions and guarantee period (01) Year. In case of failure of Contractor to fulfill/complete the work/job as per terms and condition mentioned in bid documents will be liable to forfeit the bid security in favour of state Life
