- 2- Bids will be opened in the office of Departmental Head(GS), State Life, Principal Office, 2<sup>nd</sup> Floor, State Life Building # 9, Dr. Ziauddin Ahmed Road, Karachi, on the date and time as specified above, in the presence of bidders or their representatives who wish to be present on the occasion.

- 3- All obsolete items can be checked physically at 4<sup>th</sup> floor, Hashoo Centre, State Life Building No. 12, Abdullah Haroon Road, Karachi from 2:00 p.m. to 5:00 p.m. (Monday to Friday).
- 4- The Highest Evaluated Bid would be accepted.
- 5- Bids shall accompany by a Pay Order/Bank Draft of the 5% of the total bid amount in favor of State Life Insurance Corporation of Pakistan as Earnest money. The same will be returned immediately to un-successful bidders after completion of formal procedure and to successful bidder after completion of job.
