10. Each vendor must filled Annexure-D attached with tender documents, otherwise their financial bid will not be considered.

11. Tender documents with complete specifications can be obtained from the office of the undersigned on payment of Rs.1000/- as tender fee (non-refundable) in shape of pay order/ bank draft in favour of State Life Insurance Corporation of Pakistan, Group & Pensions, Lahore.
