The contractor will design suitable/ durable metal brackets for installation of SMD (if required). The brackets shall sustain the SMD Loads, environmental pressures of wind / air / sound / humidity/ heat etc in safe manner.

SUPPLY, INSTALLATION & COMMISSIONING OF SMD SCREENS

1. Method of Procurement

1.1 Single stage one envelope procedure as per PPRA Rule – 36(a)

2. PROCEDURE FOR SUBMISSION OF BID & GENERAL TERMS:

2.1. Bid shall be submitted in a sealed envelope. Bid document (all papers) must be signed and stamped to signify the acceptance of Bid conditions.

2.2. Bid without Bid Security will be rejected.

2.3. Any conditional Bid will not be accepted and will be liable to rejection.

2.4. All the works to be carried out under the direct supervision of Admin Section (Real Estate) Principal Office, Karachi.

2.5. Payment to be made as per mode of payment.

2.6. State Life Insurance Corporation of Pakistan, will not be responsible for theft of tool / equipment or consumable material and will not accept any claim, liabilities or compensation.

2. PRE-BID VISIT:

Bidders are requested to visit the locations where screens are to be installed before submission of bid and ensure that their offers are complete in all respect. All terms & conditions mentioned in this document shall be strictly complied with. Bidder must ensure/study the specifications and B.O.Q to avoid any debate/discussion/dispute during/after execution of work. The screens will be installed on walls at height, so the bidders need to take all safety measures for their labor including technicians, Engineers etc. State Life will not be responsible for any injury / loss of life. Bidder shall arrange necessary Insurance converge for its workers.

No TA/DA will be given to Bidders for Pre-Bid Visit.

3. PRICES AND ESCALATION:

1. Quoted price shall be inclusive all Taxes, stamp duties, Transportation, Insurance, Octri, loading, unloading, lifting and fixing of equipment at Site, profit etc.

2. No price escalation claim will be entertained due to any reason of change in Taxes, Levy, Wages, Currencies fluctuation or any other change announced by the Federal Government / Provincial Government or any local Authority.

4. MODE OF PAYMENT:

1. 50% after installation of screens & remaining 50% after successful completion of work & operation of SMD for at least One (01) Month.

2. 05% Retention Money will be deducted from each bill, which will be released after successful completion of warranty period i-e One (01) year from date of completion of work.

5. WARRANTY TERMS:

1. The contractor shall furnish a completion certificate duly verified by Incharge (Admin Section) RED that the work has been completed as per B.O.Q and materials / parts supplied / installed strictly confirm to the specification as laid down in the contract.
2. The contractor will replace the components if not found according to specification or found defective due to faulty design, material or workmanship or being non-genuine.
3. Cost of removal, rechecking and cartage charges for defective materials sent back to place of manufacturing shall be borne by the contractor.

6. TIME PERIOD:

The Contractor shall complete the work within 90 days from the date of commencement of work.

7. LIQUIDATED DAMAGES:

Failure to execute the work within the stipulated time will render contractor liable to payment of liquidated damages at the rate of Rs. 5000/ day of delay subject to maximum 10% of Contract price.
