- 2. The contractor shall take maximum care of adjoining equipment and works if any damage is caused to such items, the contractor shall rectify the same free of cost to the satisfaction of State Life Engineer.
- 3. The amount of Bid security for the tender shall be Rs. 2% of bid amount. It shall be submitted in the form of Pay order / Bank Draft in favor of State Life Insurance Corporation of Pakistan.
- 4. The Bid security shall be released to the un-successful bidders after award of work to successful bidder.
- 5. The contractor shall commence the work within seven days of issuing of latter of award and shall proceed expeditiously and without delay and shall complete the works within the time for completion.
