### **Terms and Conditions of the Tender for provision of Security Services**

1. Tender will be opened in the Office of Incharge (P&GS) Department / Secretary ZPC Bahawalpur Zone in the presence of the Bidders or their representatives who choice to attend.
2. The Tenders received after the due date & time will not be entertained. The in-time collection/submission of tender will be exclusive responsibility of the bidder.
3. Rs;5000/= will be deposited by the quotationers as tender fee (non refundable).
4. The security guards preferably should be ex-army men who will have to perform their duties in shifts.
5. The submission of Professional Tax Certificate shall be mandatory for bidder.
6. All rates should be mentioned inclusive of all taxes.
7. All the taxes will be deducted as per Government Rules and Regulations.
8. Bidders are required to remit 03% of their bid (refundable) being earnest money in shape of Pay Order/DD in the name of State Life Insurance Corporation of Pakistan, otherwise bid will not be accepted.
9. The number of Security Guards can be increase/decrease as per requirement/as and when required
10. The work order will be given after signing of contract mutually.
11. Contract can be cancelled by giving one month notice period
12. The contract will be given for one year and it would be effective from the date of approval of Zonal Procurement Committee. In future the said contract can be renewed and would be extendable with same terms & conditions if mutually agreed by the both parties.
13. The security company will have to provide 12 bore Repeater or equivalent weapon, Tarch, Metal detector and Mirror to its guards.
14. Zonal Procurement Committee reserves the right to accept or reject all bids or proposal at any time prior to acceptance of a bid or proposal. However, State Life on request shall communicate any contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals. The tenders shall be required to quote the rates inclusive of all taxes.
15. Sealed Tenders duly completed in all respect must reach to the undersigned by Courier Service/by post during office hours i.e. 9:00 am to 5: 00 pm (sharp) except Saturday and Sunday.
