- 4. Bidders are required to upload their bids on EPADS systems as per laid down PPRA procedure for single stage two—envelope method i.e separate "Technical Proposal" and "Financial Proposal" respectively and clearly marked as "Purchase of Floor Standing Air Conditioners for G&P Karachi Zone". - 6. There will be a two-stage evaluation of bids. Technical evaluation will be held first. Financial bid of only technically qualified bidders would be considered for further processing.
