


## **TERMS AND CONDITIONS:-**

1. Proposals shall accompany a Pay Order/Bank Draft/CDR of not less than **Rs 30,000** in favor of State Life Insurance Corporation of Pakistan as earnest money which may be released after Final Evaluation.
2. Successful Firm/Company must submit **Rs 50000** as Performance Guarantee after award of work order which shall be returned after expiry of warranty period of supplied items and shall be subject to deductions on account of unsatisfactory delivery / performance.
3. The rates should be inclusive of all Government taxes and would be valid for 04 months (120 days) from the date of opening of financial bids. This period can be extended by SLIC with the consent of the bidder.
4. Warranty of supplied items must be valid for minimum one year or above. The supplier will be responsible to assemble/install/deliver /Ready to use items as per requirement and in case of failure to maintain quality in installation, the same will be fixed at his risk and cost besides penalty as may be imposed by Competent Authority in SLIC.
5. The earnest money would be forfeited, if the bidder fails to supply the material according to the purchase order issued.
6. The bidders will attach their respective copies of NTN and Sales Tax certificates.
7. The Bids Prices shall be lowest quoted on item wise.
8. On finding sub-standard quality as and when noticed during process, the deposited security may be forfeited in favor of the Corporation.
9. In case of any dispute the decision of the Corporation's Management will be final.
10. Tender closing date will be 04/11/2024 up to 10:00 a.m. positively, which will be opened at 10:30 a.m. on the same day on Epads.
11. Each vendor must filled Annexure-D attached with this tender document, otherwise their financial bid will not be considered.
12. The Taxes will be deducted at source on the total value of tender as per Govt. policy.
13. The Corporation may cancel/reject any one or all the tenders as per Public Procurement Rules 2004 (Rule 33(1) and Rule 35) and shall upon request communicate to any supplier or contractor who submitted a bid/proposal the grounds for its rejection of all bids or proposal, but is not required to justify those grounds.

15. PPRA rules 2004 will also be applicable.
16. The quantity of the above mentioned items can be increased or decreased at the time of issuing the work orders as per PPRA rule.
