#### 1. Introduction

State Life Insurance Corporation of Pakistan, Sialkot Zone located at Micro Plaza, Paris Road, Sialkot has appropriate budget for procurement of Computers with Display & Printers Machines for its office in District Sialkot

#### 2. Eligible Bidders

This invitation for bids on Single Stage One Envelope Procedure is open to all original manufacturers/ authorized distributors/ suppliers except as provided hereinafter by providing following documents.

- a. NTN Holder & GST Registered having Active Status on Bids opening date & time.
- **b.** Affidavit that the bidder is not blacklisted by any Government / Semi Government or any other authority and not involved in any corrupt practice or facing such type of inquiry anywhere

#### 3. Bid Security & Validity

- a) Earnest money in form of Call Deposit Receipt / Pay Order / Demand Draft in favor of State Life Insurance Corporation of Pakistan, Sialkot Zone having amount Rs. 150000/-. Successful bidder earnest money shall be retained by procuring agency (SLIC) as Performance Security up to Warranty Period & after Sales Services Effective Period which is 1-year after delivery date.
- b) <u>Bids shall remain valid up to 30-06-2025</u>, however in exceptional circumstances, SLIC may solicit the Bidders Consent to an extension of the Period of Validity as prescribed in PPRA Rules
  - If a bidder withdraws its bid during the period of bid validity specified by the bidder on the Bid Form
  - ii) In the case of a successful bidder, if the bidder fails to sign contract in this regard or submission of a fake document or fraudulent / illegal activities practice, earnest money shall be forfeited & necessary action shall be taken as per PPRA rules.
  - iii) Unsuccessful bidders bid security will be returned as soon as possible with respect to bid validity expiry by SLIC.

#### 4. Bidding Form

**a.** The bidder shall complete the Bid Form including its Bio Data Form and appropriate price schedule furnished in bidding documents indicating the brand, specification etc of items to

- be supplied, a brief description of the goods & services, quantity and prices under this contract.
- **b.** Quoted price shall be quoted in Pak Rupee only and inclusive of all applicable taxes.
- c. The successful bidder shall be required to deposit in the form of a Bank Guarantee, A Performance Bond upon execution of the contract, for Rs. 150000/-. This Bank Guarantee shall be issued by a scheduled bank operating in Pakistan and shall be kept valid from the date of issue, and should cover the warranty period after all contractual obligations have been fulfilled.
- **d.** Bidder should clearly indicate the duration of delivery of equipment in the bid/proposal

#### 5. Submission of Bids.

- a. The Earnest Money envelope should be marked for <u>Tender Notice #SLIC/ Zonal</u> <u>Office/Skt/Computer- Printer/5/2024</u>
- b. Bidder shall submit its bid through EPADS only and bid should be completed in all aspects as per prescribed bidding document. Hard copy of bid is not required through DAK. Only Earnest money for Rs. 150000/- delivery at undersigned office referred to this tender is mandatory before bids opening time and date. In case of failure EPADS downloaded bid shall not be considered.
- **c.** SLIC reserves the right to extend tender deadline for the submission of bids by amending the bidding documents referred to PPRA rules.

#### 6. Opening & Evaluation of Bids

- A. Bids will be downloaded from EPADS and subsequent opened in the office of Incharge HR & Admin Department, Micro Plaza, Paris Road, Sialkot Zone on the date and time as specified above in presence of those bidders or their authorized agents who wish to be present at the occasion. The Bidder shall submit bids which comply with tender document and alternative bid shall not be considered. Bidder can clarify its bid in writing during bids evaluation period prior to sign contract however no change in price or substance of the bid shall be sought, offered or permitted.
- **B.** The committee will examine the bids to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the document have been properly signed and generally in order
- **C.** The committee will evaluate and compare the bids which have been determined to be substantially responsive. If a bid is not substantially responsive, it will be rejected by

Procurement Committee and may not be made responsive by bidder by correction of nonconformity.

- **D.** Financial bid shall be free from all types of errors e.g. computational & arithmetical
- **E.** Any effort by a bidder to influence the SLIC during bid evaluation may result in rejection of bidder's bid with forfeiting of its bid security and blacklisting.
- **F.** State Life Insurance Corporation of Pakistan, Sialkot Zone reserves the right to invite the next bidder in case the first bidder is unable to complete pre-requisite or failed to provide requisites, required documents as per pre decided schedule inclusive of all formalities.
- **G.** Most Advantageous Bidder for Computers with Displays & Printers Lots shall be considered separately which bids shall be responsive in each lot as per least cost based w/r to required specifications.

#### 7. Award of Contract

- a) SLIC will award the contract to successful bidder whose bid has been determined to be substantially responsive and has been determined to be the lowest in Total Price of each lot, evaluated bid as per PPRA rules.
- b) SLIC reserves the right at the time of contract awarding to increase / decrease, the quantity of goods originally specified in the schedule of requirements without any change in price or other terms & conditions in accordance to prevailing rules & regulations.
- c) Failure to successful bidder to comply with the requirement regarding Supply, installation & commissioning of items shall constitute sufficient grounds for the annulment of the award and forfeiture of the bid security in which event or any other reason deems appropriate, SLIC may make award to next lowest evaluated Bidder or call for new bids.
- d) Procurement committee reserves the right to increase / decrease / withdrawal of any tender item or any tender item component at Purchase Order issuance time as per Procuring Committee recommendations which shall be final in this regard.
- e) Competent Authority reserves the right to reject all bids or proposals at any time prior to acceptance of a bid or proposal. However State Life on request shall communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejections of all bids or proposals.

#### 8. General Terms & Conditions

**a.** Upon notification acceptance by successful bidder, further **earnest money of successful bidder be retained by SLIC as performance security**.

- **b.** SLIC may require from the bidder (qualified) for submission of an integrity impact
- **c.** Bidder shall be responsible for deduction of any Duties/Taxes enforced by the Government of Pakistan during the payment of the project. The bid price MUST be inclusive of all the taxes which shall be deducted at source from payment as per Govt Rule.
- **d.** Bidder will not propose and deliver any kind of Refurbished/Used/End of Life/Near End of Life equipment and components.
- **e.** Supply should be according to required specifications. Any Defective delivery shall be taken back by supplier at his own risk & cost.
- f. 100% payment shall be paid within 30 working days upon Items delivery, installing, commissioning
- **g.** Procurement committee reserves the right to increase / decrease / withdrawal of any tender item or any tender item component at PO issuance time as per Procuring Committee recommendations which shall be final in this regard.
- **h.** No overwriting / cutting allowed on bid document.
