General Terms & Conditions:

1. Bids to be submitted at EPADS system of PPRA Tender which will be opened on **03-03-2025 at 11:00** am in the office of In-charge (HRA&P) State Life Insurance Corporation of Pakistan, Western Zone, Lahore, in the presence of bidders or their authorized agents, who wish to be present on the occasion
2. Only GST registered firms/vendor/General order suppliers (active tax payers) can participate in the tender.
3. Competent Authority reserves the right to reject any/all items or any/all bid(s) or proposals at any time before award of contract.
4. The quoted price must be irrevocable/unconditional.
5. Bid security/Earnest money must be in lump sum amount **Rs. 40,000/-** shall be deposited by the bidder/vendor in the form of CDR/Pay Order/Demand Draft favoring State Life Insurance Corporation of Pakistan (Estimated value of the procurement is **Rs. 800,000/**).
6. Bid Received after the above deadline or without Bid Security/Earnest Money and or less than required amount shall not be accepted.
7. The Successful bidder shall deposit **Rs. 64,000/-**in the form of CDR/Demand Draft/Pay Order as **Performance Guarantee** (PPRA rule 39).
8. The bid found to be the lowest/most advantages evaluated bid shall be accepted.
9. Validity of the bid will be 90 days from the date of opening of bid, which may be extendable on mutual consent.
10. Proper documentation is required for claim of tax exemption (if any).
11. Validity of the quoted rate with taxes shall be valid for 12 month from the date of opening of bid, which may be extendable for another 12 month with mutual consent.
12. The contract shall deemed to be considered as cancelled if the vendor fails to provide agreed services.

Eligibility of Applicants

Applicant cannot apply if they:-

13. Are not GST/Income Tax registered company.
14. Are bankrupt or in process of going bankrupt.
15. Have been convicted for an offence concerning the professional conduct.
16. Have not fulfilled obligations related to payment of taxes.
17. Are guilty of serious mis-interpretation or mis-representation of facts in supplying information.
18. Eligibility criteria mentioned in tender documents must be observed and fulfilled.
19. Only one PRICE for each item/job is admissible. Multiple / vague / no rates for any item will amount to cancellation of the bid. **Rate must be quoted Per Item.**
20. **Single Stage Single Envelope Procedure will be adopted.**
21. The tender Bid shall be evaluated as **One Job.**

Important Notes:

- The contractor must provide an **emergency helpline** for the duration of the contract to address any urgent repair requests.
- The contractor must adhere to all **safety standards** while working within the premises of State Life Building.
- The contractor should provide a **warranty** for any parts replaced and services rendered.
- The contractor must obtain all necessary **permissions** and comply with all relevant **legal requirements** and **local regulations**.
- **Force Majeure:** Neither party shall be held liable for delays or failure in performance due to unforeseen events beyond their control.
- **Termination:** The contract may be terminated by either party by serving **30-days notice with valid reason**.
- The bidder may visit the site/office(s) before bidding to have a clear understanding of scope of services.

- **Routine Maintenance:**
 - Monthly inspections and servicing of all air-conditioning units.
 - Cleaning of filters, coils, ducts, and checking refrigerant levels.
 - Ensuring proper cooling and operational performance of all units.
- **Repairs & Breakdown Services & Replacement of parts:**
 - Provision of emergency repairs during breakdowns, including spare parts (Defective) replacement where necessary. (After approval)
 - Ensuring all systems are back to full operation promptly.
 - Comprehensive fault diagnosis and resolution.
- **Preventive Maintenance:**
 - Regular checks of electrical components, gas levels, and other parts to prevent potential breakdowns.

1. Bidder has NTN & GST Registration Certificate.
2. Bidder must have at least 04 technicians to perform duty support staff. Provide details/list with contact number with bid and one full time technician during office hours **(9am to 5pm, Monday to Friday)** timing and days may be extended to Saturday, Sunday (if require)
3. Submission of Undertaking on legal valid and attested stamp paper Rs.100/- that the firm is not black listed by any of Provincial or Federal Government Department, Agency, Organization or Autonomous body or Private Sector Organization anywhere in Pakistan.
4. Bidder has accepted all the terms and conditions of tender documents. Attach letter.
5. Bidder must have at least 05 years experience. Attach letter.

Provide all required information with Technical Bid on letter-head pages with sign & stamp.
