# **Preamble**

Regular operation, servicing & maintenance is carried out departmentally by hiring services of contractors whereas for additions, major renovations or areas where expertise is not available departmentally, services of Consultant are desired.

Since most of the buildings are old with more than 20 years life, those require major maintenance, repairs & renovations due to life cycle completion of materials. For this purpose, State Life requires services of Consultant / Consulting firm who have expertise of design in maintenance / repairs

/ renovations of buildings. The fields of expertise required are Civil /Architecture/ Electrical / Mechanical (Lifts)/ Plumbing etc.

# 1. INVITATION:

All the eligible Consultants having valid registration with Pakistan Engineering Council (PEC) / PCATP for relevant work can participate in the bidding process for providing services for Design & Construction Supervision Of Capital Projects Of Civil/ Electrical/ Mechanical/ Plumbing For SLBs Lahore

# **INSTRUCTION TO CONSULTANTS / FIRMS**

- 1.1 The bidders will be prequalified or short listed in accordance with the criteria given in the document.
- 1.2 The Request for financial proposals of qualified Consultants will be opened on e-pads on the date to be given after completion of technical process on e-pads. The basis for award of contract will be most advantageous bid meeting the tender requirements.
- 1.3 Consultants may visit the sites (if necessary), familiarize themselves with conditions, rules & regulations of concerned authorities and take them into account prior to preparation of proposals. Consultants will be encouraged for asking any query related to the assignment and may liaise with STATE LIFE for bringing any technical insight into the assignment.
- 1.4 Consultants shall bear all costs associated with the preparation and submission of their proposals. STATE LIFE reserves the right to annul the selection process at any time prior to award of contract, without thereby incurring any liability to the Consultants.

Variations above 10% of original B.O.Q may invite *unsatisfactory* remarks from Employer with complete justification by consultant for the circumstances resulting in variations more than 10%.
