2. SCHEDULE OF SUPPLY AND INSTALLATION OF PROCURING ITEMS

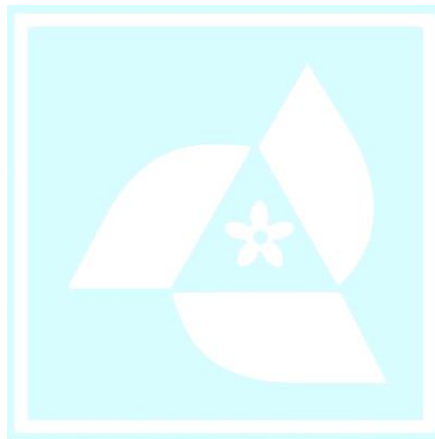
The delivery of Revolving Chairs and Air Conditioners shall be required to be completed within 2 weeks from the date of issuance of purchase / work order.

3. EXTENTION OF DELIVERY PERIOD

In special circumstances, request for extension of delivery period may be considered by the Competent Authority on the written request of the firm before the target date of supply, who will be authorized to either accept or reject the request of bidder without assigning any reason.

4. ACCEPTANCE OF BIDS AND AWARD OF PROCUREMENT CONTRACTS

The bidder with the lowest evaluated bid, if not in conflict with any other law, rules, regulations or policy of the Federal Government, shall be awarded the procurement contract, within the original or extended period of bid validity.

4. Initially only Technical Proposals will be opened and downloaded from EPADS on the opening date and time as given in tender notice. Time and date for opening of financial proposals of technically qualified bidders will be announced after finalization of Technical Evaluation and will be announced on EPAD System accordingly.
5. There will be a single stage evaluation of bids. Technical evaluation will be held first. Financial bid of only technically qualified bidders would be considered for further processing
(Technical evaluation of bid/point scoring criteria is available with bidding documents).
6. The Most Advantageous Bid would be accepted
 - i) Experience of bidders in sales / marketing of relevant equipment.
 - ii) Financial Capabilities.
