- 3 Bids will be opened / downloaded from EPADS in the office of Incharge HR & Admin Department of SLIC, Micro Plaza, Paris Road, Sialkot Zone on the date and time as specified above as per PPRA rule / EPADS
- 4 The rate validity of tender will be 31-12-2025 from the date of opening the tender.
- 5 The Most Advantageous Bidder for each item shall be considered item wise
- 6 The envelope should be marked as Bid Security for subject referred Tender Notice
- 7 Income Tax & General Sales Tax as per government rule will be deducted at the source from the payment.
- 8 Supply should be according to tender specifications. Any defective delivery / Material will be taken back by supplier at his own risk & cost. Qualification Criteria = Least Cost Based w/r to required specifications
- 9 Successful bidder will have to provide samples of material (each item), which will be examined by Zonal Procurement Committee, Supply / Work Order shall be issued upon grant of Final approval of sample by committee members
- 10 The supplier will be responsible for installation, commission of supplied items at prescribed location
- 11 The bidder shall execute work at his own cost and Quality of work shall be inspected before final payment, subsequent bidder shall be responsible to fulfill requirement as per site w/r to committee proposal
- 12 Bidder shall provide 1-year guarantee certificate of its performed work, Any repair shall be free of cost including labor & material within guarantee / warranty period by bidder
- 13 Supply items shall be brand new & according to tender specification
