- 1. Bids to be submitted at EPADS system of PPRA Tender will be opened on 31-07-2025 at 11:00 am in the office of In-charge (HRA&P) State Life Insurance Corporation of Pakistan, Western Zone, Lahore, in the presence of bidders or their authorized agents, who wish to be present on the occasion
- **2.** Only Sales Tax Registered Firms/Suppliers can participate.
- **3.** Competent Authority reserves the right to reject any/all items or any/all bid(s) or proposals at any time before award of contract.
- **4.** The quoted price must be irrevocable.
- 5. The quoted price must be inclusive of all applicable taxes as per Government Rules.
- 6. Estimated Cost of this procurement is Rs. 14,000,000/- (14.0 million).
- 7. Bid Security amount (Earnest money original) of **Rs.1,400,000/- (1.4 million)** in the shape of CDR/Pay order favoring "State Life Insurance Corporation of Pakistan" must be submitted by the bidders at the address given in tender notice / documents before closing date & time, otherwise bid will be rejected.
- **8.** Bid Received after the above deadline or without Security/Earnest money and or less than required amount shall not be accepted.
- **9.** The Successful bidder shall deposit **Rs. 1,400,000/- (1.4 million)** in the form of CDR/Demand Draft/Pay Order as **Performance Guarantee** (PPRA rule 39).

- 10. Payment will be made to the successful bidder upon successful delivery/installation of ordered items in all respects and no advance payment will be made. Payment will be processed upon satisfactory delivery/installation/commissioning of said items. In case of non-compliance or failure of execution of order within the specified time or supply of sub-standard items instead of approved and ordered items and services, Performance Guarantee shall be forfeited in favor of the State Life Corporation.
- 11. Validity of the bid will be 90 days from the date of opening of bid, which may be extendable on mutual consent.
- 12. Proper documentation is required for claim of tax exemption (if any).
- 13. Successful bidder will have to provide quoted items within 15 days at site. The bidder/supplier will be responsible to deliver/assemble/install/ready to use said items in all respect as per requirement and in case of failure to maintain quality in installation, the same will be fixed at his risk and cost besides penalty which may be imposed Rs.5000/- each day for late supply & installation of the equipment.
- **14.** The quantity of items may be increased or decreased, if desired so, by the procuring agency.
- **15.** The bid found to be the lowest/most advantages evaluated bid shall be accepted and most advantages/successful bidder shall submit original bids also signed & stamped to Secretary ZPC Lahore. Zone Western.




