1. **Bid Submission Method:**

All bidders are required to submitted manually their bids to the address mentioned in the tender notice in accordance with the **Public Procurement Rules (Single Stage – One Envelope Procedure)**. Only **prequalified bidders** may submit Sealed Financial Proposals, strictly **item-wise**, in the **prescribed format** provided in the bidding documents.

2. **Delivery Timeline & Location:**

The supply of **Desktop Computers and Laptops**, as detailed in **Annex-A1&A2**, shall be **delivered free of cost** (FOC) to designated **State Life Insurance Corporation of Pakistan** (SLIC) **offices across Pakistan** within **seven** (07) **calendar days** of the issuance of the **Purchase Order/Call-Off Order**.

3. **Bid Security Requirement:**

A Bid Security in the form of a Pay Order/Bank Draft in favor of "State Life Insurance Corporation of Pakistan" must be submitted to the address mentioned in the tender notice before the bid closing date and time. Failure to comply will result in disqualification of the bid.

4. Physical Submission Clause:

The complete bid, including all documentation, must be submitted **only manually**. However, the **original bid security** must be submitted manually at the **Central Procurement Department (CPD)** office by the given deadline. **No bid will be accepted without bid security.**

5. Item-Wise Evaluation:

Each item quoted in the Financial Proposal will be **evaluated separately**, and **award of contract** may be made on an item-by-item basis.

6. **Bid Opening:**

Proposals will be **opened** at the specified **date and time** as mentioned in the tender notice/document.

7. Quantity Variation Clause:

The total quantity of Desktop Computers and Laptops is **subject to increase or decrease** at the sole discretion of SLIC, based on requirements throughout the contract period.

8. Award of Call-Off Orders:

The **most advantageous bidder**, evaluated based on the lowest responsive offer and compliance, will be selected. **All future call-off orders** shall be issued **only** to this bidder during the contract period.

9. **Non-Obligation Clause:**

State Life is **not bound** to procure any or all quantities mentioned in the **Bill of Quantities** (**BOQ**) during the contract term. Payment shall be made **only for the quantities** successfully delivered, installed, and verified under individual Call-Off Orders.

10. Earnest Money/Bid Security Amounts:

11. For **Desktop Computers (Item Nos. 01 to 03)**: Rs. **1,400,000/-**

12. For Laptops (Item Nos. 04 to 08): Rs. 500,000/-

Bid security shall be returned to **unsuccessful bidders** after the evaluation process and to the **successful bidder** after issuance of the Purchase Order or signing of the agreement, as applicable.

13. Performance Guarantee:

The successful bidder shall provide a **Performance Guarantee equivalent to 05%** of each Call-Off Order value. This amount shall be **deducted at the time of payment** and retained **until completion of the warranty period**, after which it will be released upon **satisfactory completion and performance**.

14. **Price Inclusivity:**

All quoted prices must be **inclusive of all applicable taxes**, **duties**, **and levies**, including **G.S.T.** In the absence of explicit mention, it shall be presumed that the prices quoted are **inclusive of all applicable taxes**.

15. **Bid Validity:**

The Financial Proposal shall remain valid and binding for a **minimum period of one (01) year** from the date of signing the agreement under the Closed Framework Arrangement.

16. Failure to Deliver:

If the successful bidder **fails to deliver** the goods as per the Purchase Order terms, the **Performance Guarantee shall be forfeited** without prejudice to any other remedies available to the Purchaser.

17. **Right to Reject Bids:**

The Competent Authority reserves the right to accept or reject any or all bids/proposals at any time prior to the acceptance of a bid in accordance with Rule 33 of the PPRA Rules 2004.

18. **Confidentiality:**

All bidders shall treat all documents, specifications, and other information provided during the bidding process as **strictly confidential** and shall not disclose them to any third party unless authorized in writing by the Purchaser.

19. **Dispute Resolution:**

Any dispute arising out of this procurement process shall be resolved amicably, failing which it shall be dealt in line with PPRA Rules.

20. Blacklisting:

Failure to comply with any terms of the contract may lead to the bidder being **blacklisted** under Rule 19 of PPRA Rules and as per State Life Black listing policy.

FRAMEWORK AGREEMENT

For the Procurement of Computers, Laptops, and Provision of Three-Year After-Sales Support (Including Parts & Labor)

This Agreement is made on this ____ day of ______, 20, at [City], Pakistan.

BY AND BETWEEN:

State Life Insurance Corporation of Pakistan, established under [Act/Ordinance], with its principal office located at [Complete Address] (hereinafter referred to as the "Purchaser", which expression shall, where the context so permits, include its successors, legal representatives, and permitted assigns),

AND

[Name of Supplier/Vendor], a company duly incorporated under the Companies Act, 2017, having its registered office at [Address] (hereinafter referred to as the "Supplier", which expression shall, where the context so permits, include its successors, legal representatives, and permitted assigns).

RECITALS

WHEREAS:

- The Purchaser, in accordance with the Public Procurement Regulatory Authority (PPRA) Rules, 2004, initiated a competitive bidding process via Tender No. [] dated [] for the establishment of a Framework Agreement for the supply and after Sales Service on site of computer and laptop;
- The Supplier, having been declared the successful bidder, has agreed to supply the Goods and provide Services as per the terms of this Agreement;
- The Purchaser wishes to enter into a closed Framework Agreement for a period of one (1) year, during which Call-Off Purchase Orders shall be issued on an as-needed basis for the offices listed in Annexures A-1 and A-2.

NOW, THEREFORE, the Parties agree as follows:

1. SCOPE OF SUPPLY AND SERVICES

- 1.1 The Supplier shall supply, deliver, install, and maintain the Goods in accordance with the technical specifications detailed in Annexures B-1 to B-8.
- 1.2 The Supplier shall provide comprehensive after-sales support, including labor, spare parts, and technical assistance, for a period of three (3) years from the date of installation.
- 1.3 The Goods shall be delivered to the locations specified in Annexure A-1 & A2, covering the Principal Office, Regional Offices, and Zonal Offices throughout Pakistan.

2. TERM OF AGREEMENT

- 2.1 This Framework Agreement shall remain valid for a period of one (1) year from the Effective Date.
- 2.2 Purchase Orders (Call-Offs) may be issued at any time within the validity period.
- 2.3 No other supplier shall be authorized to supply the Goods covered under this Agreement during its term.
- 2.4 The following documents shall be deemed integral parts of this Agreement:
 - Tender Documents
 - Bid submitted by the successful Supplier

• Any additional clauses required in line with agreement prior to the signing of this Agreement

3. TECHNICAL SPECIFICATIONS & WARRANTY

- 3.1 Detailed technical specifications are provided in Annexures B-1 and B-2.
- 3.2 All equipment must be brand new, of genuine make, and accompanied by a minimum three
- (3) years comprehensive warranty (including labor and parts). Where the OEM does not provide a 3-year warranty, the Supplier shall provide equivalent coverage.

4. PRICES AND PAYMENT TERMS

- 4.1 Prices shall be fixed and remain unchanged throughout the term of the Agreement.
- 4.2 Payment shall be made within thirty (30) days of successful delivery, installation, and commissioning of the Goods, upon submission of a valid invoice supported by a Delivery and Installation Report signed by the end user and countersigned by an authorized Purchaser representative.

5. PERFORMANCE SECURITY

5.1 A Performance Security equivalent to 05% of the value of each Call-Off Purchase Order shall be deducted from the Supplier's invoice and retained for the duration of the warranty period. It shall be released upon the successful and satisfactory completion of said period.

6. DELIVERY AND INSTALLATION

- 6.1 The Supplier shall deliver and install the Goods within seven (7) calendar days from the date of each Purchase Order. Any request for an extension due to genuine reasons must be submitted in writing and may be accepted at the sole discretion of the Purchaser.
- 6.2 Installation shall be performed at the locations mentioned in the respective Purchase Order, at no additional cost to the Purchaser.

7. AFTER-SALES SERVICE OBLIGATIONS

- 7.1 The Supplier shall provide full after-sales support free of cost including parts and labur, including but not limited to:
 - Free on-site repairs
 - Replacement of defective components
 - Equipment replacement, if required2
 - Quarterly preventive maintenance
 - 24/7 helpdesk support or an escalation mechanism
- 7.2 Service Response Time:
 - **Critical faults:** Within 24 hours
 - **Minor faults:** Within 72 hours
 - **Equipment replacement:** Within 7 working days
- 7.3 Non-compliance with after-sales service obligations may result in penalties or termination as per Clause 11.

8. LIQUIDATED DAMAGES

8.1 In the event of delayed delivery or installation, the Purchaser reserves the right to impose liquidated damages at a rate of 0.5% of the Purchase Order value per day, up to a maximum of 10%.

9. INSPECTION AND ACCEPTANCE

- 9.1 All Goods shall be subject to inspection by the Purchaser's designated technical team.
- 9.2 Final acceptance shall be confirmed upon successful delivery, installation, and issuance of an Acceptance Certificate by the authorized Purchaser representative.

10. TERMINATION

- 10.1 The Purchaser reserves the right to terminate this Agreement, without liability, under the following circumstances:
 - Repeated failure of the Supplier to fulfill obligations
 - Supply of substandard or counterfeit equipment
 - Supplier's insolvency or bankruptcy

11. DISPUTE RESOLUTION

- 11.1 All disputes arising out of this Agreement shall, in the first instance, be resolved amicably between the Parties.
- 11.2 If unresolved, the matter shall be referred for resolution as per applicable PPRA Rules.

12. GOVERNING LAW

12.1 This Agreement shall be governed by and construed in accordance with the laws of the Islamic Republic of Pakistan and the Public Procurement Rules, 2004.

13. MISCELLANEOUS

- 13.1 This Agreement, including all annexures and documents referenced herein, constitutes the entire understanding between the Parties.
- 13.2 Any modifications or amendments shall only be valid if made in writing and duly signed by authorized representatives of both Parties.
