- 2. Bidders should provide the name of firm, complete postal address, Telephone No, Fax No, Email address and web address (if any).
- 3. Bid security shall be submitted separately for each item quoted. Bids without the prescribed bid security shall be rejected.
- 4. The procurement will be carried out on an item-wise basis. Bidders may quote for one item or both items
- 5. Bids can be submitted/uploaded at EPADS till closing time 11:00 AM on 07-10-2025.
- 6. Submitted bids shall be opened at **11:30 AM on same day i.e., 07-10-2025**, at HR&A Department, State Life Insurance Corporation of Pakistan, Group & Pension Karachi Zone, 6TH Floor State Life Building # 2 Wallace Road Karachi in the presence of bidders or their authorized agents, who wish to be present on the occasion.
- Bidders are required to submit their bids in a sealed large envelope, clearly marked "Supply of of FLOOR-STANDING TOWER AND SPLIT AIR CONDITIONERS". For Single Stage Single Envelope Method.
- 8. Bids will be opened in the office In-Charge (HR&G),G&P (Karachi Zone), 6th floor, State Life Building # 02, Wallace Road, Karachi, on the date and time as specified in the specifications & quantities /schedule above, in the presence of bidders or their representatives.
- 9. Quote only single rate for each item, which must be irrevocable, unconditional & inclusive of all taxes & expenses (if any).
- 10. There will be a single-stage evaluation of bids. Technical evaluation will be held first, financial bids of only technically qualified bidders will be opened. Minimum overall 60% for the bidders to technically qualify.
- i) Experience of bidders in sales / marketing of relevant equipment.
- ii) Financial Capabilities.
- iii) Number of existing clients provided with similar equipment.
- iv) List of professionals on permanent strength- for installation and after sales services
- 11. The Bid Security will be returned to un-successful bidders after completion of formal procedure and to successful bidder immediately after completion of work. However, successful bidder will be required to submit performance guarantee of 3% (value of Job Order) in shape of bank guarantee (valid for at least One Year & warranty period) in favor of State Life Insurance Corporation of Pakistan which shall be released after expiry of one year after completion of job.

- 12 Bid validity period up to 31.12.2025.
- 13. The vendor's office or site office must be located at Karachi.
- 14. All the bids must include all government taxes.
- 15. SLIC can increase or decrease the quantity of items to be purchased and also reserve the right to accept or reject any or all tenders/Bids in line with PPRA rules.
- 16. Warranty of the items will start from the date of delivery.
- 17. If the successful bidder fails to supply the items as per purchase order, the bid security will be forfeited.
- 18. Competent Authority reserves the right to reject all bids or proposal any time prior to the acceptance of a bid or proposal in the light of PPRA rules.
- 19. All the information provided by the bidder must be verifiable.
- 20. No advance payment shall be made. Payment will be processed upon satisfactory delivery and installation of items. In case of non-compliance, failure to execute the order within the specified time, or supply of substandard items/services, the Performance Guarantee shall be forfeited in favor of the Corporation.
- 21. Earnest money of the successful bidder will be forfeited if the items are not delivered within due time or extended delivery time. In case of a genuine reason regarding delay in delivery the successful bidder shall inform immediately and the delivery time may be extended at the discretion of state Life.
- 22. Successful bidder will have to start supply/job within 3 days after confirmed work order and must complete the supply in all respects within 10 working days; otherwise retention money (CDR) will be forfeited. In addition to this liquidity damages as penalty may be imposed after expiry of 10 working days, at 1% per day of the total purchased order value.
- 23. Substandard or unbranded items will not be considered.
- 24. In case wherein on bid opening day, holiday announced by prevailing Government or Zonal Office could not operate due to unavoidable reasons, then bid opening meeting shall be held on very next working day.

25. Eligibility criteria mentioned below must be observed and fulfilled. An Affidavit of Rs. 100 (non judicial stamp paper) in this regard must be attached with the bid.
