# **Terms & Conditions:**

- 1. Bidders must submit their bids through "EPADS" adopting "single stage single envelop procedure"
- 2. Bid Security amounting to 3% of bid value in form of Pay order / Demand Draft in Favor of State Life Insurance Corporation of Pakistan Multan Zone must be submitted to the office of undersigned in original in a sealed envelope on or before closing date by hand, which will be refunded to the unsuccessful bidder upon completion of formal procurement process and earnest money of successful bidder will be retained and converted into performance guarantee and will be returned after expiry of warranty period of supplied items/six months after completion of work and shall be subject to deductions on account of unsatisfactory performance. No bid will be accepted without earnest money.
- 3. The bidders will have to attach copies of their company profile, Experience related documents, Managerial capacity, Financial position, Active STN (where applicable) with the tender. These documents are required for evaluation purpose as every slot has 10 numbers each and minimum qualifying marks are 30. CDR and Active Status of NTN is compulsory requirement.
- 4. The prices quoted must be inclusive of all duties /Govt. taxes packing, and delivery charges. If GST is applicable, the same should be shown separately. The quotations will be considered as including all taxes. In case of any type of tax exemption all valid required documents i.e. Exemption certificate, deduction at source etc. must be attached with the quotation.
- 5. The Prices mentioned in the tender will be treated as firm till the completion of Work Order. The Prices must be stated both in words and figures in Pakistan Currency.
- 6. The most advantageous Bid would be accepted. If the successful bidder fails to complete the job as per the specification and quality, the work order shall be canceled, purchase will be made from next advantageous bidder.
- 7. If a bidder submits the rates of item which is equivalent to our demanded brand, he is bound to provide all the required specifications which justify the equivalence of goods.
- 8. Bid will not be accepted if a vender is under litigation with State Life or blacklisted by any of Provincial or Federal Government Department, Agency, Organization or autonomous body or Private Sector Organization anywhere in Pakistan. Personal influence will also disqualify bidders.
- 9. The successful bidder is bound to supply the contract items/services according to quoted rates and specifications at state life 5<sup>th</sup> Floor Multan Zone.
- 10. No price difference in the market will affect your quoted rate in any condition. The rates should be market driven, in case the rates does not match with the market control rates the committee reserve the right to cancel/reject the said item after assigning proper reason, in the best interest of corporation.
- 11. No advance payment will be made. Payment will be processed upon satisfactory delivery/Installation of items or completion of work/services. In case of non-compliance or failure of execution of order within the specified time or supply of sub-standard items and Services, the earnest money shall be forfeited in favor of the Corporation.
- 12. Maintenance Period/After Sales Services (For Product Inspection Visits/Cleaning/Repairing) Warranty of the supplied items must be mentioned and remain valid for mentioned year. The supplier will be responsible to assemble/install/deliver the items as per requirement and incase of

failure to maintain quality of installation, the same will be fixed at his risk and cost besides penalty as may be imposed by Competent Authority in SLIC.

- 13. Bid validity period shall be 60 Days from the date of opening of bids. This period can be extended by SLIC with the consent of bidders.
- 14. The Corporation/Competent Authority reserves the rights to cancel reject any one item out of listed items, any one lot or the entire tender in accordance with rule 33 of PPRA Rules. However, State Life shall upon request communicate to any bidder who submitted a bid or proposal, the grounds for its rejection out of all bids or proposals.
- 15. Evaluation of items/work will be made as a whole basis.
- 16. Firm or its representative must visit the Office for necessary measurement, designs of products, layout plan, materials to be used and all other relevant details clarification etc. before submitting a bid.
