- The Bid Security shall be released to the unsuccessful bidders after awarding of work to the successful bidder.
- The contractor shall commence the work within (07) days of issuing of a letter of award and shall process expeditiously and without delay and shall complete the works within the time for completion.
- Penalty for late completion of work shall be Rs.7,000/- (Rupees One Thousand Only) per day subject to a maximum of 10% of the contract amount.
