- 1. Bidders should provide the name of firm, complete postal address, Telephone No, Email Address, and web address (if any)
- Bidders are required to visit at Karachi Eastern Zone between 09.00am to 5.00pm and sample must be seen before quoting rates. Items shall be finalized as per approved sample only and inferior quality samples will not be accepted and bid of the respective supplier will be rejected.
- 3. Bidders are required to upload their bids on EPADS system as per laid down PPRA procedure for single stage one-envelope method i.e. technical details and financial rates in the same pdf. The proposal shall be marked as "Purchase of Furniture Items for Area Manager & Field Force". However, original bid security in shape of pay order must be submitted at the address given in tender notice before closing time else tender will be rejected and soft copy of the same shall be submitted through EPADS mandatorily.
- 4. Proposals will be opened and downloaded from EPADS on the opening date and time as given in the tender documents.
- 5. For the evaluation purpose initially the required documents will be checked first in line with tender documents and if found compliant then the sample of the respective bidder will be checked in connection with the submitted rate i.e starting with the lowest quoted rates and if found inferior quality the bid will be rejected and samples of the next most advantageous bidder be checked to finalize the tendering process.
- 6. The lowest evaluated most advantageous will be selected based on the supply of all items only. No separated individual items of different bidders will be accepted / selected for the evaluation and tender finalization process. Accordingly, for comparison of lowest evaluated/ most advantageous bidder rates will be compared for supply of whole consignment.
- 7. The tender will be awarded to lowest evaluated /most advantageous bidder meeting both criteria as mentioned in the above clause.
- 8. All the participating bidders shall submit bid security amount of Rs. 100,000/- in shape of Pay Order in favor of the SLIC, along with their bid submission through EPADS system.
- 9. Bid Security will be returned to un-successful bidders after completion of formal procedure and to successful after issuance of purchase order / signing of contract.
- 10. No bid will be accepted without bid security.
- 11. All bids must include all government taxes.
- 12. Most advantageous bidder will be required to deliver items within 20 days after issuance of Purchase Order.
