1. The bid shall comprise a single packet containing two separate envelopes inside; each envelope shall contain separately the Financial Bid and the Technical Bid.

4. After Technical Evaluation, envelope of Financial Bid of technically accepted bidder will be opened with prior intimation to all qualified bidder.
5. The Financial Bid of technically disqualified bidder will be returned unopened to the respective bidders / their authorized representatives.
6. All queries / clarification required from bidder shall be addressed on working days fax or letter at the address given below up to one week prior to close of Bid submission date. No clarification shall give to telephone.

The security company will provide copy of discharge book, police verification, finger print report, character certificate etc. before deployment of security guards.
2. The security company will provide complete uniform with badges, cap, and shoes etc, extra uniform as & when needed.
3. The security company will provide shoot guns / Raffle (semi-automatic) and pistols / Revolvers in good & working condition duly licensed by the Government,& Security Equipment's the details is given below :
 - Hand Held Metal Detector at main entrance
 - Explosive / Mirror Detector for Cars
 - Any other security & safety related equipment as required for proper checking of visitors & vehicles.
 - Power full Torch / Search Light for use during Power Failure / Night




