- V.** Tenders not accompanied by Bid Security Deposit and tender cost in the prescribed form shall be summarily rejected. Suppliers are required to sign & stamp each and every page of tender documents. Incomplete/ partial and inappropriate tender documents will not be entertained/ considered.
